Other leave-on products and oral products - 0.0002%	

**"Safrole, Isosafrole and/or Dihydrosafrole** as such should not be used as fragrance ingredients. The natural extracts containing Safrole, Isosafrole and/or Dihydrosafrole should not be used as substitutes for these ingredients. "

The level of Toluene has to be kept as low as practicable and should never exceed 100 ppm in the fragrance compound/mixture or fragrance oil. Should not be used as a fragrance ingredient.
